Henry Morgenthau, who contributed \$1,000 to Sulzer's campaign, testified before the Court of Impeachment today that on September 2, 1913, immediately after his return from abroad, Governor Sulzer called him on the long distance telephone.

"After congratulating me on my safe return," Mr. Morgenthau testified, "he asked me to come to Albany. I told him I could not, as I was planning to go to Washington in relation to the Federal position to which I had been appointed."

KUHNE NOW ON RACK ON WALDO CHARGES

Police Captain Accused of Failure to Suppress Gambling.

Close on the heels of Commissioner Waldo's sudden and unexpected personal visit to the gambling dens of Chinatown last night and the transfer of Captain Frank A. Tierney, Sergeant Owen J. Keegan and Detective Louis Gray of that precinct, came the announcement from Headquarters today that charges had been preferred against Captain August Kuhne of the Lenox avenue station, also for failure to suppress or report gambling in his precinct.
